Stay Online LLC and Stay Online s.r.o. Custom Quote Terms and Conditions of Sale

AGREEMENT. The sale of products by Stay Online LLC (StayOnline) to Buyer is expressly conditioned upon Buyer's agreement to every term contained herein, which shall control over any additional, inconsistent or contrary provision in Buyer's purchase order or other forms, shall not be binding upon StayOnline. Buyer acknowledges that the terms and conditions herein are the sole and complete agreement between the parties, which may only be modified and/or amended in a separate agreement signed both by StayOnline and Buyer.

PAYMENT. Subject to credit approval and unless otherwise stated in StayOnline's quotation, Buyer shall make payment within thirty (30) days of the invoice date. StayOnline may charge a service charge of 1.5% per month, if Buyer has not paid an invoice in full by the due date. StayOnline may at any time decline to make any shipment or perform any work except upon Buyer's payment of past invoices. Payment for shipments delayed at Buyer's request shall be invoiced on the date StayOnline is prepared to make shipment. Payment to StayOnline shall not be contingent on third party payments to Buyer. Buyer shall pay all costs and expenses, including reasonable attorney's fees, incurred by StayOnline to collect any past due amount.

SHIPMENT. All products are sold, and all shipments are made, FCA or EXW. The shipment date stated in any quote is StayOnline's best approximation of the probable shipment date and is not a fixed or guaranteed shipment date. StayOnline shall not be liable for any damage or loss resulting, whether directly or indirectly, from delayed shipments or its inability to ship as quoted. Unless otherwise noted in any quote, partial shipments may be made upon request and may be subject to additional shipping and handling charges.

CANCELLATION/CHANGES/RETURNS. Some items sold by StayOnline are Non-Cancellable Non-Returnable (NCNR) and will be noted on www.stayonline.com or a prepared quote. If other than NCNR Buyer may return an order, subject to any applicable restocking fee, only after obtaining a Cancellation Authorization or Return Material Authorization from StayOnline. StayOnline reserves the option to make changes to products which do not affect form, fit, or function.

PRICES. All prices are subject to change without notice in the event of any changes in cost of materials or labor, specifications, quantities, delivery schedules, customs duties, other factors beyond Seller's control, or in the event of delays caused by instructions of the Buyer, or failure of the Buyer to give Seller adequate information. Prices do not include taxes, including but not limited to Value Added Tax (VAT) or excise taxes, sale taxes, duties, tariffs, or any other costs assessed by a governmental authority.

TECHNICAL/PROPRIETARY INFORMATION Proprietary information, including drawings, documents, technical data, reports, designs, inventions and other technical information supplied by Seller in connection herewith, shall remain Seller's sole property and shall be held in confidence by Buyer. Data shall not be reproduced, used or disclosed to others by Buyer without Seller's prior written consent.
